

What is Digital Equity?

We first saw reference to digital equity related topics in 1995 when the National Telecommunications and Information Administration (NTIA) put out an article about the digital divide. As advances in technology started booming, this gap between those who have access to and an understanding of technology grew. By 2001, when a study coined the term digital equity, people began to recognize that something needed to be done about the problem.

Since these articles came out people have been working to close this digital access gap. All states are now required to have a plan in place for providing digital equity services to follow guidelines laid out by the Digital Equity Act first introduced in 2019 and made official in 2021. These services must include three parts - internet, devices and digital skills. This is often described as a three-legged stool and without one of the legs the other services aren't as useful.

Part of Minnesota's plan includes working with community organizations to provide services. The Office of Broadband Development calls these partners a Digital Connection Committee (DCC). These committees can be political subdivisions, tribes, non-profits, anchor institutions, faith-based organizations, Minnesota-based businesses, or just interested individuals. Minnesota had some focus areas to implement their plan including aging individuals, incarcerated individuals, veterans, individuals with disabilities, individuals with language barriers, individuals who primarily reside in a rural area and individuals of a low-income household. So, the idea was that committee could help provide services to one or more of these underserved communities.

Recent statistics from the 2022 Census are showing that we still have a lot of work to do. Majority of the US is still only around 80-85 percent covered with some states having little to no coverage at all. Funding is always the main problem when it comes to offering services like digital equity. The Digital Equity Act only had a five-year plan and we have already run out on plans like the Affordable Connectivity Program (ACP). You might be asking yourself, what's next?

There is hope with the Digital Equity Competitive Grant Program and local grant funding. The Competitive Grant just closed so those who applied will get updates within the next year. As for Minnesotans specifically check on any grants coming from the Department of Employment and Economic Development (DEED) website. Anyone connected to education, housing, libraries, healthcare, workforce, nonprofit or other community support organizations please apply.

Article Definitions

Affordable Connectivity Program [FCC]

The Affordable Connectivity Program (ACP) was a Federal Communications Commission (FCC) benefit program that helped ensure that households could afford the broadband they need for work, school, healthcare and more.

Digital Connection Committee [DEED]

As the Office of Broadband Development develops the Digital Equity Plan to strategize improvements in internet affordability, access to internet-enabled devices, and access to digital skills training, Digital Connection Committees serve as key partners in ensuring the Plan reflects the goals and needs of all Minnesotans. Committees are voluntary workgroups which OBD is supporting

Digital Divide [NTIA]

The gap between people who have access to modern information and communications technology and those who don't.

Digital Equity [NDIA]

A condition in which all individuals and communities have the information technology capacity needed for full participation in our society, democracy and economy. Digital Equity is necessary for civic and cultural participation, employment, lifelong learning, and access to essential services. Sometimes called TEQuity/Tech Equity which is the shortening of technology equity.
