Minnesota's Digital Opportunity Plan

In 2021 the Digital Equity Act was a law passed to help create grants to fund digital inclusion programs within the US. Each state had to come up with a plan for what to do with this funding. Minnesota outlines their objectives in an almost 400-page document called the MN Digital Opportunity Plan (DOP).

It is important to review the information provided within the DOP as there are multiple state grants that will be coming out soon for organizations to get funding. This article will only be going over certain parts of the document so be sure to check out the full plan linked in the resource section listed after the article.

The vision of Minnesota's DOP is "a future where comprehensive digital access connects all Minnesota residents to opportunities, options, and each other." It lays out three goals and four objectives to follow in order to make progress. See them list below.

Goals: Connect People to People, Connect People to Information, Connect People to Resources **Objectives:** Internet adoption, Devices, Digital skills, Accessibility

Digital Divide

In 1995 an article by the National Telecommunications and Information Administration (NTIA) brought to attention the issue of what is called the digital divide. Originally it was about those who have cellphones and those without, today it has been expanded to include all technology. An updated definition of the digital divide is "the gap between people who have access to modern information and communications technology and those who don't."

Within the digital equity world, closing the digital divide is often portrayed as a three-leg stool. Each leg represents a part of a system that gives someone proper digital access. The digital access stool only stays standing (functions) if someone has access to all three legs. These three parts are internet, devices and digital skills.

Digital Connection Committee

A Digital Connection Committee (DCC) serves as a key partner in ensuring the Digital Opportunity Plan reflects the goals and needs of all Minnesotans. Committees are voluntary workgroups which the Office of Broadband Development (OBD) is supporting. They "can be formed by a variety of entities, including political subdivisions, tribes, non-profits, anchor institutions, faith-based organizations, Minnesota-based businesses, and more – or any combination of these. Individuals are also welcome to sit on Digital Connection Committees without being affiliated with a formal organization."

As part of the strategy for the DOP Minnesota looks to these committees to help them provide the state digital equity services.

Focus Areas

Minnesota has listed a few groups that are often underserved when it comes to digital equity services. Anyone providing these services needs to be sure to include and/or even focus on these groups. These groups are: Aging individuals, Incarcerated individuals, Veterans, Individuals with disabilities, Individuals with a language barrier (both English learners and low literacy individuals, Individuals who are members of a racial or ethnic minority group, Individuals who primarily reside in a rural area and Individuals of a Low-Income Household.

Future Funding

To conclude, the Minnesota Digital Opportunity Plan brings up more opportunities for organizations to receive funding. The state and committees have been gathering data to better plan for where the funding is needed. They "heard from thousands of Minnesotans about the role technology plays in helping them achieve their quality-of-life goals. Across these perspectives, access to technology consistently means access to education, access to healthcare, access to career advancement, access to housing, and access to basic government services."

Groups who should apply for funding: Public schools, Public or multi-family housing authorities, Libraries, Medical or healthcare providers, Community colleges or other institutions of higher education, Other nonprofit or governmental community support organizations and Workforce agencies.

With the potential for more funding Minnesota continues to strive for digital equity. Follow the Department of Employment and Economic Development (DEED) website to keep up to date with grants and other funding opportunities available.

NDIA's Important Words

Digital Equity

A condition in which all individuals and communities have the information technology capacity needed for full participation in our society, democracy and economy. Digital Equity is necessary for civic and cultural participation, employment, lifelong learning, and access to essential services. Sometimes called TEQuity/Tech Equity which is the shortening of technology equity.

Digital Literacy

The ability to use information and communication technologies to find, evaluate, create, and communicate information, requiring both cognitive and technical skills.

Digital Navigators

Trusted guides who assist community members with ongoing, individualized support for accessing affordable and appropriate connectivity, devices, and digital skills.
