

"Do you need help paying your rent?"

Section 1: Program Information

Purpose of the Program: The Section 8 Program is a voucher program that helps people with low-income afford their housing. The program is funded through the federal government but is managed by local Public Housing Authorities (PHAs). If you qualify for Section 8, you will pay 30-40% of your income for housing and Section 8 will pay the rest. There is also a Section 8 Homeownership Program, which helps to buy a home and meet monthly expenses of homeownership.

Deadline: You can apply at any time, as long as the Public Housing Authority has an open waiting list. It is suggested to apply to multiple Public Housing Authorities, as you are more likely to receive services sooner.

Note: Some Public Housing Authorities do not cover Section 8-Under the 'Type' column, look for the words 'Combined' or 'Section 8'.

Section 2: Eligibility Requirements

Basic Eligibility: The exact income limits vary by area, and can be found by visiting the Housing and Urban Development website here:

https://www.huduser.gov/portal/datasets/il.html. Households with lower than 50% of median income may qualify, although most households that receive Section 8 have lower than 30% of the median income in the area.

In the Twin Cities Metro Area, here are the average limits, although it can vary from city to city.

NOTE: HUD generally uses the Office of Management and Budget (OMB) area definitions in the calculation of income limit program parameters. However, to ensure that program parameters do not vary significantly due to area definition changes, HUD has used custom geographic definitions for the Minneapolis-St. Paul-Bloomington, MN-WI HUD Metro FMR Area.

The Minneapolis-St. Paul-Bloomington, MN-WI HUD Metro FMR Area contains the following areas: Anoka County, MN; Carver County, MN; Chisago County, MN; Dakota County, MN; Hennepin County, MN; Isanti County, MN; Ramsey County, MN; Scott County, MN; Sherburne County, MN; Washington County, MN; Wright County, MN; Pierce County, WI; and St. Croix County, WI.

- Additional factors are considered with your application, including:
 - Past history with federal housing programs
 - Criminal background
 - Credit History

Section 3: Application Process

Every Housing Authority has its own, separate application to complete.

You will need the following information:

- How many people live in your household
- □ How the members of your household are related
- □ How much income you have
- □ If you have a disability

Warning: If you need help with your application, you can get it from your local Housing Authority Staff - NEVER pay for an application or voucher as it is illegal

Section 4: Expectations (What will happen?)

What is the timeline for receiving services?

- Unfortunately, even if you qualify for Section 8, you probably won't be able to receive assistance right away.
- Section 8 can only help a limited amount of people at a time. The wait time varies between Public Housing Authorities, but most waiting lists are either several years long or not open at all, meaning you cannot even submit an application at this time.
- The typical wait time to receive Section 8 Assistance is several years.

With whom will participants be communicating?

What additional steps must participants take to receive services?

- If you qualify for a Section 8 Housing voucher, you will still need to find a place to live.
- The place will have to be within size and rent limits, and the landlord must accept Section 8 as payment
